# ANNUAL REPORT FOR THE FINANCIAL YEAR 2010-'11 SUBMITTED BY THE PRESIDENT, PAMENCAP, GODAVARIKHANI IN THE GENERAL BODY MEETING OF PARENTS ON – 23/04/2011.

#### **Dear Parent Members**,

It gives me immense pleasure to present the Annual Report on the important achievements / activities of our PAMENCAP, Godavarikhani during the year 2010-'11, it is again a historical year in the feather of PAMENCAP.

- Myself, Sri B. Ramakrishna Reddy, Secretary and Sri J. Laxminarayana, Treasurer visited Vijayawada and opened a Bank Account in Axis Bank for getting funds from a Donor for the growth of our organization.
- As permitted by the Committee and with my own initiation, we have entered into MoU with M/s. Give India Funding organization for national and international has given a task for registration and with the help of office staff and with Computer operator, we have finally succeeded in registering two activities and we are hopeful to receive the help from the said organization.
- We are making our best efforts for getting help from abroad and to make the Corpus Fund to Crore considering the stoppage / less sanction of help from GOI / National Trust.
- I have guided the office staff and Accountant in preparation of audited accounts and grant file for the year 2010-'11 and submitted information to the Chartered Accountant for preparation of audited statements and grant file with a volume of around 200 pages was submitted to the Asst. Director, Disabled Welfare, Karimnagar. The inspection was arranged on 21.04.2010 in view of my proposed trip / visit to USA.
- We are happy that sanction of non-recurring items i.e., 'Unisol' Solar Water heating System for the usage of Mano-Samarth Hostel, Physiotherapy equipment, Teaching aids worth of Rs. 1,07,000/- obtained were spent on 31.03.2010 with my initiation.
- I have requested the Patron of Manochaitanya Sri A. Manohar Rao, CGM, RG-1 to provide sanction of Iron Stand for keeping the 1000 Ltrs. Sintex Water Tank, which was approved and advised AGM (AWS) and Civil Dept. to execute the work. Finally the work was executed and with the help of service departments and hot water connection was successfully arranged.
- I have proceeded to United States of America, Jacksonville, Florida on my personal leave from 29.04.2010 to 10.07.2010 to attend my family trip.
- I have coordinated the Manochaitanya / PAMENCAP works from USA over phone as mentioned below:
  - Grant-in-Aid proposals in the O/o. the Asst. Director, O/o. the Joint Collector, O/o. Collector for the year 2010-'11 by involving by taking help of Sri D. Sridhar Babu, Hon'ble Minister of AP Higher Education & NRI Affairs.
  - With my follow up, not only our file, the file pertaining to PAMENCAP, Satya Sai School, Jammikunta favorably.
  - o Under my guidance, the Grant-in-Aid file with the recommendation of Collector, Karimnagar submitted in the O/o. Commissioner, Disabled Welfare, AP, Hyderabad in five copies.
  - o I have contacted and followed up with the authorities of M/s. Sitaram Jindal Foundation (Jindal Alluminium), Jindal Nagar, Tumkur Road, Bangalore. Finally, Mr. N.Murali, Liaison Asst. Mgr., visited Manochaitanya. I made all arrangements by involving all our active parents and executive committee members. I spoke and requested SO to CGM and CGM, RG-1 for sparing their time for his visit and stay.
  - o Mr. N. Murali was received with good honour and spared my personal Car and Driver for his travel from RGM and local.
  - Finally with the help of Civil authorities and SO CGM and CGM, RG-1, a plan with detailed estimations were sent to M/s. Sitaram Jindal authorities and I was informed that are going to donate around Rs. 15.00 Lakhs for 50% the construction of 1<sup>st</sup> floor on the existing Hostel building and the balance 50% in the next year.
  - Our Income Tax 80G exemption was expired on 31.03.2010. I submitted for renewal of the proposals during the month on 2<sup>nd</sup> Feb., 2010. The first hearing was attended by our Secretary, our Accountant and Chartered Accountant. On 10<sup>th</sup> May, I prepared all the documents before I left for abroad and I guided all our colleagues for effective presentation of our case before the Income Tax authorities. The hearing was postponed for 2<sup>nd</sup> hearing on 2<sup>nd</sup> June, 2010. They have put a condition for registration of our PAMENCAP under Endowment Act. We have completed the formality without effecting our present structure / way of working. Again the hearing was postponed to 16<sup>th</sup> July, 2010.
  - As per my schedule, I should report for duty on 22<sup>nd</sup> July by reaching India on 21<sup>st</sup> July. But when I contacted my colleagues of PAMENCAP / Manochaitanya and Chartered Accountant Mr. Satish, I was told that the Commissioner of Income-Tax has appreciated our work and put a condition that they require my presence on the day of hearing i.e. 16<sup>th</sup> July, 2010. Accordingly, I rescheduled my visit and pre-poned my schedule to 10<sup>th</sup> July and reached India.
- Regarding the developments taken place during my stay at USA, a separate report is being enclosed for kind perusal & ready reference.
- I received a donation of \$3600 to PAMENCAP, Godavarikhani and deposited in FCRA account.
- I have also guided our staff and spoke to the NTPC authorities regarding handing over of 36,600 Nos. Note Books of worth Rs.4,75,932/- to NTPC with the personal initiation of Sri M. Venkata Ramana our Vocational Instructor who is under deputation from S.C. Educational Society. This major work has been went smoothly.
- There is a lot of wastage of paper was accumulated in the Hand Made Paper Unit. I arranged the sale of same and received useful paper boards from M/s Gandhi Paper Mart, Durished, Karimnagar.

- On 16<sup>th</sup> July I have attended the Commissioner, Income Tax 80G hearing due to increase in the Volume of work / worth beyond Rs. 10.00 Lakhs. The Commissioner of Income Tax made a technical objection and verbally rejected our appeal for exemption of 80G.
- Our Chartered Accountant felt nerves and I took a special permission to represent our case in a different angle and I could made him to understand the difficulty in extracting the work from the Mentally Challenged which probably except one or two institutions are doing in the State and no private job reservations was made available in these Mentally Challenged sector. I have shown the special help of SCCL authorities and other private and Non Government authorities and with a argument and appeal of more than 40 minutes, the Commissioner convinced to accord exemption as a special case even though the limit exceed Rs. 10.00 Lakhs and I am very happy to submit that our institution / organization was given 3 years exemption under 80G. Copy enclosed for kind perusal.
- I am continuing my contacts developed during stay at USA for the future developments of our organization and some of the NRIs are planning to visit Manochaitanya in their upcoming visit to India.
- I have conducted two Parents meetings and Executive Body meetings to involve most of the parents in day to day and developmental activities.
- The 'SAMARTH' which was headed by National Trust, the Grant-in-Aid proposals and submitted thro' courier to the National Trust authorities, New Delhi.
- Under my guidance, the proposals for consideration of our application / candidature for presentation of four National Awards Best Individual, Best Institution, Best Employee (V. Praveen Kumar) and Best Creative Disabled (Ms. D.Sai Jyothi) in triplicate thro' Director, NIMH with all documentary evidences.
- I am happy to submit that his holiness Paramahamsa Parivrajakulu Sri Sri Sri Tridandi Chinajeeyar Swami Jee sent his kind blessings to us (copy enclosed).
- With my initiation Sri J.Babu, Deputy E.E., PR, Peddapalli and Mr. N.Balakishan, A.E., MPP, Ramagundam have visited Manochaitanya and prepared estimates for construction of Dining Hall worth of Rs.1.5 Lakhs with the funds allocated by MPP, Ramagundam, though there is lot of objection for allocation of funds to the urban/municipal area. I could succeed about the sanction with my appeal and convincing nature.
- Mr. B.Venkata Praveen Kumar of California, USA visited Manochaitanya on his own and assured for his help and also impressing upon his friends to come forward to help Manochaitanya.
- Sri Ramesh, MSW working in MPP office, Kamanpur visited Manochaitanya and agreed to support to the teaching staff and organization with his knowledge and experience.
- Mr. S.V.Ramana Murthy, SBH, Manager (who is the elder brother of Mr. Raju Sangam, who gave \$1000 from Jacksonville, USA) and his wife Smt. Padmaja (Child Psychologist) with his disabled son from Hyderabad, visited Manochaitanya and appreciated the efforts, later interacted with the CGM, RG-I for admitting his son in Manochaitanya VTC, he want to opt a transfer to SBH, Godavarikhani.
- On 03.08.2010, 'Bhoomi Pooja' was carried out for construction of Dining Hall in Manochaitanya premises with the financial help of Smt. Kusuma Prameela, Ambika Hospitals, GDK.
- In a programme arranged on 28.09.2010, the Bus Passes (concession) have been distributed to the children by the Depot. Manager, APSRTC, GDK and Municipal Commissioner, RGM.
- Mr. & Mrs. Ch.Aditya Murthy & Shirisha, resident of Bangalore visited Manochaitanya with their 27 days kid and distributed sweets, fruits, presented a gift worth of Rs.1000/- of Lord Venkateshwara musical electronic photo frame.
- I have attended on invitation the PARIVAAR executive council meeting in the capacity of Chief Vice President of AP and participated in various meaningful discussions and invited the state President Sri B.Ramjoga Rao and his team for forming self help groups.
- Sri B.Ramjoga Rao, 84 Yrs. old aged person, President State PARIVAAR, Founder of Lekhadeep, Hyderabad accompanied by his 53 Yrs. old Mentally Challenged Son and Smt. T.Vijaya Laxmi, Joint secretary, State PARIVAAR & Founder Prerana School, Hyderabad accompanied by Smt. G.Vijaya Laxmi visited Manochaitanya and conducted parents meeting and formed 2 self help groups for preparation of Phenyle, Surf and Chalkpiece making unit and presented Rs.15,000/-. Later I have contacted CGM, Mandamarri and P.M., & Parents Association, Mandamarri and conducted parents meeting by using my personal vehicle, I made every arrangement for their convenient stay and their send-off.
- On 6<sup>th</sup> & 7<sup>th</sup> October, 2010, training to Community Coaches was arranged at Karimnagar for conducting of Sports & Games for the persons with disability. The Training programme was attended by Ms. Malathi, Smt. Swarnalatha and Sri Raju of Manochaitanya.
- The Internal Audit Dept., SCCL/RGM is conducting auditing of 2008-'09 accounts of PAMENCAP / Manochaitanya. In this connection, the required documents, registers, etc. are fed to them for timely completing of audit.
- Smt. Swarnalatha was appointed as Asst. Teacher and Smt. Kanthamma, was appointed as Ayah in the month of September, 2010 for providing required guidance and to help the Mentally Challenged children.
- For National Awards for the year 2010-'11, from PAMENCAP / Manochaitanya, GDK, nominations were sent for
  - "Best Institution working for the Cause of Persons with Disabilities" to MANOCHAITANYA.
  - "Best Individual (including professional) working for the cause of Persons with Disabilities" to Mr. D.KRISHNA KUMAR.
  - "The Best Employee" to Mr. VINJAMOORI PRAVEEN KUMAR, Mentally Challenged person.
  - "The Out Standing Creative Child with Disabilities" to Ms. DONTHULA SAI JYOTHI.
- Smt. Kalvakuntla Kavitha, Founder & President of 'Telangana Jagruti Foundation' D/o K.Chandra Shekhar Rao, President TRS visited Manochaitanya on the eve of Mental Health Protection Day (on 10/10/2010) and 'Koti Batukamma Jathara'. Our parents, Staff and Mentally Challenged Children, organizers of 'Telangana Jagruti Foundation' including Smt. K.Kavitha played 'Batukamma' in Manochaitanya and hostel and appreciated the efforts and volunteered for extending all possible help to Manochaitanya. In the evening, the children have been taken to Jawaharlal Nehru Stadium, GDK to witness the 'Batukamma' competitions which was very much enjoyed by the children.

- With the help of our computer operator I could explain the website redesign activity at Hyderabad, Geniewebs so as to enable us to convey a meaningful message to the donors in India & across the World.
- I made required follow-up Sri Jagannatha Chary, AGM (Civil), CGM/RG-I and S.E. Civil/RG-I regarding construction of Dining Hall, the matter is under a speed progress.
- I am making required follow-up with the authorities of State Govt., Ministry of Social Justice and Empowerment for getting a suitable Grant to our Organisation during this financial year, I am also making constant follow-up with authorities of National Trust for required help.
- I have visited Aurangabad, Maharashtra 4 days for attending PARIVAAR General Body meet and National Parents Meet organized by NIMH in which I could interact with Ms. Poonam Natrajan, Hon'ble Chairperson, National Trust and impressed by her lecture and I submitted a CD/DVD copy and brief on my USA visit. And requested Hon'ble Chairperson for revising the norms of National Trust pertaining to Samarth Scheme (meant for hostlers).
- Pandit Potukuchi Nageshwara Shastri, Vijayawada visited and presented steel glasses for each child and blessed the inmates and appreciated the efforts of PAMENCAP.
- Sri Gattu Narayana Guru Jee, Chairman Emeritus, M/s. Excel Industries has visited Manochaitanya and opined that the Institution is a Temple of Humanity and Divinity to care of special children and the mission of Mr. D.Krishna Kumar is very much appreciable.
